Harry Bosch is a fictional character in the novels of Michael Connelly, the author of twenty-eight previous novels including #1 New York Times bestsellers *The Crossing* and *The Burning Room*.

Connelly's books have sold more than sixty million copies worldwide and been translated into thirty-nine foreign languages. He is a former newspaper reporter who worked the crime beat at *The Los Angeles Times* and *The Fort Lauderdale Sun-Sentinel* and has won numerous awards for his journalism and his novels.

Retired after a 30 year LAPD career, mostly spent as a maverick homicide detective, Harry finds himself unable to leave police work behind. (Sound familiar?) So he puts his skills to good use as a reserve police officer for San Fernando PD, the home of CRPOA General Counsel and Reserve Sergeant Jim Rene, and is assigned as a cold case detective.

I had a hard time putting **The Wrong Side of Goodbye** down as Harry tracked a serial rapist who proved to be one of the most baffling and dangerous criminals he has ever faced. The book comes complete with a scene in which a cop from another agency orders Harry from his vehicle and Harry tells him, "Relax, I'm a police officer," and tenders his flat badge and ID. Met with a sneering, "This says you're a reserve," Harry aggressively retorts, "That's right. I used to be full-time and now I'm part time." (Again, sound familiar?) The irony of that scene is that the police ID's of San Fernando PD reserve police officers say nothing about being a reserve, but who am I to quibble? – it makes for a good story line!



# Note from CRPOA General Counsel



## The War on Cops and the California DOJ

I'm reading an excellent book authorized by Heather McDonald called "The War on Cops." You can find it on Amazon. It is a scholarly, dispassionate look at the various social and political forces which have emerged in the past decade relative to law enforcement and the many mistruths, distortions and flat-out lies propagated by groups eager on advancing their causes at any cost. While one might view it as a political commentary, I prefer to see it as a fact-based analysis of the various police use of force cases which so often appear in the media as "typical" examples of law enforcement killing members of our society for no other reason than the color of their skin when in fact these cases were completely justified use of force situations passing muster under the "reasonableness" standard set forth in the Supreme Court's *Graham v. Connor* decision. I highly recommend you get a copy of the War on Cops and read it word for word.

The relevance of Ms. McDonald's book on what is happening in our suit against the DOJ regarding the DOJ's view that reserves are not "sworn peace officers" within the meaning of the exemption for acquiring patrol rifles under Penal Code Section 30630(b)(1) could not be more clear. To me, there is simply no other explanation for DOJ's sudden and still legally unexplained position that somehow reserves are not "sworn peace officers" than it is a purely politically-driven agenda to show that DOJ is "doing something" in furtherance of gun control, even if it means removing a tried and true law enforcement tool, the patrol rifle, from use by reserve peace officers. Although DOJ may smugly assert that reserves can still use department-supplied patrol rifles, in many cases no such patrol rifles exist and, even if they did, many departments are now reluctant to allow reserves to even touch patrol rifles while they work the streets of our State. For many of us now, we have effectively been banned by a policy which has no other purpose than to disarm the police in furtherance of what I believe is the DOJ's own "war on cops."

To update you on where we stand with our suit at present, as we go to press with this article, we will have a trial-setting conference in court at which the judge will set a trial date which we expect will be sometime in the spring of 2017. The wheels of justice grind slowly and I wish we could move this along at a faster pace, but this is how our court system works.

Hang in there, we are fighting for you and your ability (and more importantly your right under the Penal Code) to protect yourselves and the public as you patrol the streets of your cities and counties. It's a dangerous time for all of us, so stay safe and stay tuned for more developments as we seek to right the egregious wrong DOJ is pursuing in furtherance of their misguided "policy" but in unabashed violation of California law.

# Reserve Coordinator Training

*Are all of the reserve peace officers in your agency  
duly selected, appropriately appointed  
and properly trained?*

While the Reserve Coordinator Training Course is not a requirement for the position, we want to emphasize its importance. It should be given priority by every agency that utilizes reserves as part of their law enforcement training. On December 12th through the 14th of this year, a three day, 24-hour Reserve Coordinators Course will be offered at Golden West College – Regional CJTC in Huntington Beach, CA. If you have a Reserve Coordinator that has not completed this training, please call (714) 895-8925 for enrollment information.

The class is designed to provide new techniques, skills, and abilities for managing reserve peace officer volunteer organizations. Emphasis is placed upon the recruitment, selection, retention, training and assignment of volunteers within a law enforcement agency. A well-managed reserve program can be a valuable asset to your agency and your community.



## YOUR **CRPOA** MEMBER RECORD . . . It's your responsibility to keep it accurate!

In July of this year we entered the world of paperless invoicing for our individual members. Auto bill agencies will continue to receive paper invoices with a list of the members covered. This process has proved successful from both a cost saving and security standpoint. If your agency is paying for your annual membership, which includes insurance and legal support, you are very fortunate. A word of caution, however, few agencies take the time to update changes to your personal membership information with our office. Changes to your personal data such as your home address, phone numbers, and your email address that you have provided CRPOA are rarely corrected by your

agency on your behalf. **It is best that you take the time to keep this information accurate.** If you are handling your own membership administration, keeping this information up-to-date resides solely with you.
