## 2024 DIRECTOR CANDIDATE NOMINATION PETITION

### INSTRUCTIONS

1. All information submitted on the Director Candidate Nomination Petition must be the same as that on file with the Association. Discrepancies will result in rejection of any entry with an error.
2. A candidate must have become a General Member on or before **May 31, 2022** and must be in good standing (dues current) on the date the Nomination Petition is received by the Association and continuously thereafter.
3. Petitions must include no less than 10 nominators, each of whom must be a General Member in good standing with the Association on the date the Nomination Petition is received by the Association. A candidate may be one of the nominators for his or her own Nomination Petition. In order to ensure that a Nomination Petition is not rejected due to the lack of enough nominators (e.g. one or more nominators is not a General Member in good standing), it is suggested that more than the minimum of ten nominators be submitted.
4. The 10 nominators must represent at least three different law enforcement agencies. For example, three nominators may be presently or formally affiliated with the San Mateo County Sheriff's Office, three from the Los Angeles Police Department and four from the Santa Clara Police Department.
5. Signed Petitions must be received at the Association office not later than 11:59 p.m. on **April 1, 2024**. Copies of the signed Nomination Petition are acceptable.
6. Candidates are invited, but not required, to submit a Statement of Candidacy, not exceeding 250 words in length. Statements more than 250 words will be rejected. Statements will be published exactly as submitted, including spelling and grammatical errors. Statements must be in a Microsoft Word format without italics, bold or underlining. No boxes, frames, or items other than ordinary alphabetic and numeric characters will be accepted. Statements must accompany the Nominating Petition and will not be accepted separately.
7. General Members may be any of the following:
  - a. Currently active reserve peace officers; or,
  - b. Retired reserve peace officers; or, (For this purpose, "retired" refers to any former reserve peace officer who was retired or separated from service under honorable conditions).
  - c. Currently appointed search and rescue team members; or,
  - d. Currently appointed volunteers in policing.
8. Agency means:
  - a. The agency by which a currently active reserve peace officer was appointed; or,
  - b. The agency from which a former reserve peace officer was retired or separated from service; or, (See 7.b. above)
  - c. The agency by which a current search and rescue member or volunteer in policing was appointed.
